GDPR – General Data Protection Regulations. (Feb 2018)

The following questions should be considered: - when writing a privacy notice:

What information is being collected ? - **Only the data collected on the membership form**

Who is collecting it ? - **The membership secretary. Held on personal computer which is password protected.**

How is it collected ? - **On the membership forms**

Why is it being collected ? - **To assist the membership secretary for auditable trails and proof of membership.**

How will it be used ? - **To maintain membership lists and for the treasurer to maintain auditable trail of monies received.**

Who will it be shared with ? - **As a contact list for treasurer, membership secretary and for section heads to be agreed beforehand before entry into the programme/schedule.**

It is advised that land line and home address are not advertised together.

What will be the effect of this on the individuals concerned ? - **There should be no effect.**

Is the intended use likely to cause individuals to object or complain ? - **No. Should issues or concerns arise members should contact the Chairman and membership secretary.**

However, this will be monitored and members should contact the Chairman and membership secretary for investigation.

The Goosnargh and Longridge Agricultural Show take your privacy very seriously and will only use your personal information to administer the membership list to provide tickets / wristbands and where agreed declare section contact details in our schedule and programme.

From time to time we may need to share your contact details with other members of the main committee. If you consent to this please sign and date.
